Pursuant to Iowa Code §123.32(7), your appeal of the DENIAL of your liquor license application by the Council Bluffs City Council, will be heard by the Iowa Alcoholic Beverages Division Administrator's Designee. The hearing in this matter will be conducted in accordance with Iowa Code chapters 17A and 123, and this division's administrative rules. The appeal hearing on this matter will be held at **2:30 PM, on the 28th day of July, 2014.**

The hearing will be held by telephone.

**INSTRUCTIONS TO PARTICIPATE IN THE TELEPHONE HEARING:**

We are now using a telephone conference calling system for hearings. You can participate from any location where you have a telephone.

**At the date and time scheduled for hearing, you must do the following:**

- Call 1-866-685-1580
- When prompted, enter the following Conference Code Number: **0009991671**(press # after entering the number)
- The system will ask if you are the leader. **YOU ARE NOT -- DO NOT PRESS THE \* KEY**
- The system will ask you to state your first and last name
- You will be put on hold until the judge enters the conference call; stay on the line until the judge enters the call.

**Important information about participating in the hearing:**

- You may call in as early as five minutes before your hearing is scheduled to begin (example: if your hearing is scheduled to begin at 9:00 AM, you may call as early as 8:55 AM).
- The judge will wait five minutes after the time the hearing is scheduled to start to allow all parties to call in. If you have not called in by five minutes after the hearing is scheduled to start, the judge may enter a default judgment against you.
- **It is your responsibility to call in for the hearing. The judge will not call you. If you do not call using the above instructions, you will not be able to participate in the**

hearing. If you have any technical difficulties connecting at the time of the hearing, please call Meggan at (515)281-6343.

- If you wish to submit exhibits or documentary evidence into the hearing record, please mail or FAX them to the attention of the administrative law judge prior to the hearing. You must also mail or FAX copies to all parties.
- If you are planning to present witness testimony at the hearing, you may have the witnesses with you, provided you have a speaker phone. In the alternative, you may have your witnesses call in to the hearing, using the number and code provided in this notice, or you can provide the telephone numbers of your witnesses at the time of the hearing, and the judge can connect them to the conference call when you are ready to present their testimony.
