Dear Mr. Overmyer,

On May 6, 2014, the Iowa Alcoholic Beverages Division received your application for renewal of a class "C" liquor license, which was denied by the Council Bluffs City Council.

You may appeal the Council Bluffs City Council's denial of your application by filing a written Notice of Appeal with the Iowa Alcoholic Beverages Division. The Notice of Appeal must be received by Annie Adamovicz, Alcoholic Beverages Division, 1918 SE Hulsizer Rd., Ankeny, Iowa 50021, within thirty days from your receipt of this letter.

If a Notice of Appeal is filed, you may continue to sell liquor, beer and wine in and on the premises known as O Face Bar, located at 2400 9th Ave, in Council Bluffs, Iowa, until such time that the Administrator's designee hears the matters and issues a written decision. Please note, as a condition to this "timely filing" status, the Division has deposited your online payment in the amount of \$2,028.00 and has retained the renewal license application.

If you do not file a Notice of Appeal, all selling of liquor, beer and wine must cease on the thirty-first day from your receipt of this letter. You may apply for refund of the unused quarters of the license fee at that time.
