The Iowa Department of Public Safety, pursuant to authority granted in Iowa Code section 123.14, hereby makes the following complaint against the above-named licensee.

1. Iowa Code section 123.39 permits the Administrator of the Alcoholic Beverages Division to suspend or revoke a liquor control license of any licensee who violates any of the provisions of chapter 123.

2. Iowa Code section 123.49(1) provides that no person shall sell, dispense, or give an alcoholic liquor, wine, or beer to an intoxicated person.

3. On or about November 11, 2012, the licensee, or an agent or employee of the licensee, sold, dispensed, or gave an alcoholic beverage or beer to a person who was intoxicated at the time.

WHEREFORE, the Iowa Department of Public Safety requests that the Administrator find violations of § 123.49(1), and pursuant to § 123.39, enter an appropriate civil penalty.
